1. GENERAL TENDER CONDITONS

- 1.1 The conditions, specifications and schedules contained in this document form an integral part of the tender contract and must be returned with the tender submitted. Failure to comply herewith will invalidate a tender.
- 1.2 This document contains continuously numbered pages and is the copyright of the Municipality of George. It may not be used, copied or lent out except in the performance of this contract.
- 1.3 Tenderers should carefully inspect the document for completeness and legibility. Claims based on missing pages or illegible script will not be considered.
- 1.4 Telegraphic tenders will be considered, provided that the tender document is posted before the advertised closing time of tender. Proof of the date and time of posting shall be required. **FAX OFFERS WILL NOT BE VALID.**
- 1.5 Late, incomplete, open or unmarked tenders will not be considered.
- 1.6 Proof of posting will not be accepted as proof of delivery.
- 1.7 **Tenders shall remain valid for 120 days after closing date of tender.**
- 1.8 **Written information only will be valid as amending** or supplementing this contract. Verbal information will not be accepted as binding on Council or its officials.
- 1.9 **Each tender must be submitted in a sealed envelope clearly endorsed "TENDER NO ENG 025-/16: THE SUPPLY AND DELIVERY OF ELECTRICAL STOCK: LED STREET LIGHTS AND POST TOPS" and addressed to The Municipal Manager, Municipality, PO Box 19, GEORGE, 6530, so as to reach him not later than the date and time advertised or be placed in the tender box situated at Supply Chain Management, The George Civic Centre (1st floor), York Street, George.**

Tenders shall be valid from date of appointment for a three (03) year period and items will be ordered from the successful tenderers as and when required.
- 1.10 All prices quoted and all deposits or payments made shall be in the currency of the Republic of South Africa.
- 1.11 Tenders must be submitted on the schedule provided and completed and signed in all respects.
- 1.12 The lowest or any tender will not necessarily be accepted and Council reserves the right to accept any tender in whole or in part.
- 1.13 Any deviation or omissions from or additions to the specifications or additional or alternate items shall be detailed in the variation schedule. Deviations or omissions not speechified shall not be accepted.

Any additional particulars should be furnished in a separate letter by tenderers.
- 1.14 Tenderers must submit: the prices of all optional equipment separately, the terms and conditions of guarantee, delivery time, availability and prices of and discounts on spare parts, full descriptive literature and specifications, and choices where applicable.

1.15 Contract Price Adjustment:

1.15.1 Prices should remain firm for the period of the tender. Should the successful Tenderer wish to alter any tendered price during the currency of this tender, Council reserves the right to:

- i) Accept the amended price
- ii) Call new tenders for the affected items.
- iii) Negotiate prices with alternate suppliers.

1.15.2 Where prices are not firm, a formula using the SEIFSA indexes is to be used and the following shall apply:-

- i) Tendered prices shall be based on the latest published index figures.
- ii) The adjusted contract price shall be coupled to the tendered delivery times and not the actual delivery date (e.g. if the tendered delivery time is 6 months and the order is placed in August, contract adjustment shall be calculated with February as agreed completion month). The actual delivery time shall be used to adjust the contract price where delivery time is shorter than the tendered delivery time.
- iii) Should Council be of the opinion that prices have risen out of proportion; Council reserves the right to negotiate on the open market for provision of the goods.
- iv) Successful tenderers must submit on request all the applicable formulas, constants and factors required for calculating price adjustments.

1.16 All invoices submitted for payment shall be accompanied by a CPA calculation sheet clearly showing all calculations where prices are subject to adjustment.

1.17 Test Certificates:

Where applicable, test certificates will be required and tenderers must state the additional cost for the submission thereof, if any.

1.18 Brochures:

All additional information brochures etc. required or which the Contractor wishes to submit with or in support of his tender, shall be submitted in duplicate.

1.19 Defective materials:

Should materials or equipment be found defective within one year after being supplied, or unsatisfactory in any way, the Council may order such defects or unsatisfactory materials to be replaced free of cost and that such replacements be subjected to one year guarantee.

1.20 Value Added Tax:

All prices must INCLUDE 14% V.A.T.

1.21 Quantities:

The minimum quantities given are the minimum quantities per any one order. More than the minimum amount may be ordered and more than one order may be placed during the year. Tenderers are free to specify discounts for large quantities.

1.22 Samples:

If so required, samples MUST be submitted to the Director: Electro technical Services, Municipal Offices, Brick Road, George. If this clause is not complied with, tenders will not be considered. The samples of accepted tenders will be held for the whole of the contract period for reference.

Tenders must also clearly state whether samples are to be returned or whether they are FREE OR CHARGED. In the absence of an indication in this regard, samples will be retained without future responsibility.

1.23 Quality and Guarantee:

- 1.23.1 All goods supplied shall be equal in all respects to samples, patterns of specifications where such are provided and where no samples or patterns are exhibited, or specifications maintained, then the goods or materials shall be the best of their respective kinds.
- 1.23.2 Council reserves the right to inspect any goods at any time during the production, testing or commissioning stage and may accept or reject any goods in part or as a whole that do not comply with this specification.
- 1.23.3 Any deliveries not equal to samples and/or not in accordance with the Contract or otherwise unsatisfactory will be rejected, and such rejected goods will be held at the risk and experience of the Contractor and must, if required, be removed by him immediately on receipt of notification of rejection. The fact that no objection was made at the time goods were delivered shall not affect the Council's rights under this clause.
- 1.23.4 Council reserves the right to request test certificates for specified items. If the tested samples meet the specification, Council will pay all the cost of such test. If the tested samples fail to meet the specification, the supplier shall pay the costs of testing, as well as removing all defective articles that may have been delivered and replacing with acceptable items.
- 1.23.5 If any dispute arises between the Council and the Contractor in connection with the quality and guarantee of the goods, either party may give to the other notice, in writing, of the existence of such dispute, and the same shall there upon be referred to arbitration in South Africa to a person to be mutually agreed upon. The submission shall be deemed to be a submission to arbitration within the meaning of the arbitration within the meaning of the arbitration laws in force in the Republic of South Africa.
- 1.23.6 The risk on all goods purchased by the Council under the Contract shall remain with the Contractor until such goods have been delivered to the Council.
- 1.23.7 The Form of Tender, Variation Schedule and Price Adjustment Schedule shall be completed by the Tenderer, and shall be submitted with his Tender on the tender closing date.
- 1.24 Delay in completion:
Should the Contractor fail to complete the delivery to the satisfaction of the Engineer within the period stated the Contractor shall pay the Employer as and for agreed liquidated damages the sum of 1/14% (one fourteenth percent) of the total contract amount per calendar day which sum the contractor agrees to forfeit for each and every calendar day the delivery remains incomplete after the expiration of the given period, and it is hereby agreed that in the above event the Employer shall have the right to realize all or any of the securities and apply the proceeds towards the payment of any claim under this or any other clause of these conditions of the contract. When the total of the abovementioned penalties reaches 5% of the contract value and the delivery is still incomplete, the Employer shall exercise procedures as set out in the General Conditions of Contract.
- 1.25 Escalation fees:
In the event of prices being subject to adjustment, such escalation fees shall only be payable up to and including the last day stated in the delivery schedule for items being delivered late.
- 1.26. A successful tenderer shall be notified of the award of a tender in writing, signed by the Municipal Manager or the Head of Department responsible for the contract. A verbal notification of award shall not be accepted as binding on the City Council of George.

TECHNICAL SPECIFICATION FOR SUPPLY AND DELIVERY OF LED STREETLIGHT LUMINAIRES AND POST TOP LUMINAIRES

1 GENERAL

- 1.1** This part of the specification deals with the supply and delivery of LED Streetlight and Post Top Luminaires to the George Municipality.
- 1.2** Complete technical details, specifications and copies of test certificates of the luminaires offered shall be submitted with the tender. Tenders received without the documentation will not be considered.
- 1.3** The proposed luminaires must comply with both the minimum mechanical specification and to the specified photometric requirement per road in the tender.
- 1.4** Tenderers to complete the technical return schedule as well as a simulation for each line item from a Computer calculation program that conforms with the requirements of CIE and CEN (Below mentioned) and are certified as such by either CIE or CEN – certified proof to be provided. Further to this, for each luminaire offered, the photometric file of this luminaire shall be supplied on a disk.
- 1.4.1** Technical report CIE140 (2000), Road Lighting Calculations, published by *Commission Internationale de l’Eclairage (CIE)*; and
- 1.4.2** CEN standard EN 13201 – 3 (2003), Road lighting - Part 3: Calculation of performance.
- 1.5** As the nature of replacement involves the removal of old technology and replacement with new, the street light poles and mounting heights cannot be changed and these simulations will be used as a basis to gauge the performance of the luminaires offered. The municipality in turn will make use of the most appropriate luminaire to suit the existing installation based on the choices in this specification.
- 1.6** All luminaires shall be delivered to George Municipality, George facilities for storage. Each luminaire shall be delivered completely assembled ready for use and shall be individually packed in suitable and sturdy containers such as cardboard boxes. The internal packaging shall be such that no damage shall occur to the luminaire (during normal handling). The containers shall be marked with appropriate description and stock code of the luminaire contained within.
- 1.7** Tenderers shall submit a summary of the percentage of local content with their offered product.

2 STANDARD TECHNICAL SPECIFICATION

2.1 All luminaires supplied under this contract shall be of a quality and class most suitable for working under the conditions specified and shall withstand the variations of temperature and atmospheric conditions that may arise without distortion, deterioration or the setting up of undue stresses in any part such as to affect the efficiency and reliability of the plant, and also without affecting the strength and suitability of the various parts for functions which they have to perform.

2.2 LUMINAIRE

2.2.1 The LED luminaires shall be designed to comply with the lighting criteria for the different road classes as specified in the schedules in accordance with SANS 10098.

2.2.2 The luminaire shall be designed in accordance with the following requirements:

- a) Design life: Minimum of 25 years
- b) The replacement (upgrading and service) of the LED unit and the driver/power supply shall be possible without removing the whole luminaire but by means of replacing only the optical/gear compartment by means of a hinging mechanism (or similar).
- c) The luminaire shall incorporate a temperature sensor which monitors the temperature of the LEDs on the PCBs. Once a critical temperature is reached, the current shall be reduced to a safe temperature level. The temperature sensor shall not completely switch off the LEDs at high temperatures, which shall facilitate maintenance to be undertaken during daylight hours.
- d) The power supply or driver shall be able to withstand surges of up to 10kV/10kA by means of an external inline fused surge protection device mounted inside the gear compartment. This surge protection shall be easily replaceable.
- e) The power supply or driver should incorporate a thermal switch to prevent exceeding the case temperature for maximum life time of equipment. The lifetime of the power supply or driver shall be 100 000hrs with 90% survival over the lifetime.
- f) Minimum IP rating of the light compartment, including driver compartment: IP66. Test reports must be provided.
- g) The protector shall be smooth, for easy cleaning, and shall be manufactured of tempered glass (IK08) or high-impact acrylic (IK10). Test reports must be provided.
- h) It shall be certified, in terms of IEC 60598, to operate at an ambient temperature of 35°C. The thermal design shall be particularly designed for African exterior conditions, i.e. high temperatures, high pollution, corrosion resistant.
- i) The cooling fins shall be designed in such a manner to prevent the accumulation of dirt, thus ensuring the continuous effective cooling.
- j) The LED module or array shall be designed in such a manner that the failure of one LED shall not cause additional LED's to switch –off. Documentary evidence of this shall be submitted
- k) The LED life expectancy shall be 60,000 hours at 80% lumen maintenance. (Documentary evidence from the LED manufacturer, by means of an appropriate datasheet, confirming the statistical correlation, shall be provided).
- l) Use of high efficiency LED's (> 70 lumens/watt: Absolute photometry) CRI > 70 . Documentary evidence of compliance to this clause shall be submitted with the tender.
- m) Colour temperature shall be neutral white (4 000K) with an option to be supplied in warm white (3000K).
- n) A report from the LED vendor, for LED's used in the luminaire, shall be submitted, which shall

include the following documentary evidence:

- Measured LED junction temperature for a given test condition and extrapolated for an ambient temperature of 35°C. □ LED drive current.
 - LED manufacturer data that clearly correlates LED junction temperature and LED drive current to lumen maintenance.
 - The LED datasheets, indicating the Byy, Lxx data, as provided by the LED manufacturer.
 - Documentary evidence, confirming that the failure of one LED will not cause additional LED's to fail.
- o) Direct conduction & maximized surface for external heat exchange shall be provided.
- p) The luminaire housing shall be constructed of marine grade high pressure die cast aluminium, painted grey. Tenderers shall submit a metallurgical report from an independent metallurgist confirming the grade of aluminium for all the luminaires offered. The housing shall be robustly constructed, weatherproof, hailproof, insectproof, corrosion proof, ultraviolet light resistant and vandal resistant.
- q) Luminaire closure shall be by means of two movement clip mechanism at the rear of the luminaire and secured by a tamper-proof screw to minimise theft and vandalism.
- r) The control gear compartment shall be incorporated into the luminaire housing.
- s) The power supply connection must take place inside the luminaire.
- t) The luminaire shall automatically disconnect the supply to the power supply once the luminaire is opened.

2.3 SPIGOT ENTRIES

- 2.3.1 Spigot entries shall be designed to fit easily over the bracket pipe (42mm in diameter) and shall be truly parallel to the fitting axis and shall comply with SANS 1088.
- 2.3.2 The luminaire shall be secured to the spigot by means of at least two stainless steel M8 grub screws into stainless steel sockets or any other methods to prevent cathodic corrosion between stainless steel and aluminium. This shall be done from the inside of the luminaire to minimise the risk of vandalism and theft. Additional safety mechanisms to minimise theft and vandalism should be considered.
- 2.3.3 The attachment of the luminaire should be designed to withstand wind speeds of up to 150 km/hour on the projected surface of the luminaire, without due deflection.

2.4 POWER SUPPLY

- 2.4.1 The power factor shall be rated at ≥ 0.9 .
- 2.4.2 The power supply shall be removable and shall be suitable for operation with the specified rating of the lamp on a 108-305VAC 50Hz single phase system.
- 2.4.3 Operating temperatures shall be from -15deg to +45deg on the housing (case temperature).
- 2.4.4 Operating humidity shall be from 20% to 95%.
- 2.4.5 Provisions shall be made to withstand surges up to 10kV/10kA.
- 2.4.6 The unit shall be EMC compliant to the EN55015 and EN61347-1 standard.
- 2.4.7 The unit shall provide the option to add a daylight sensor, on the low voltage side.
- 2.4.8 The lifetime of the power supply or driven shall be 80 000hrs with 90% survival over the lifetime.

2.5 LED STREETLIGHT LUMINAIRE MARKINGS

- 2.5.1 Each luminaire shall bear the name or trade mark of the manufacturer and the date of manufacture.
- 2.5.2 Each luminaire shall be distinctly marked with black writing on a white background using 25 mm

high lettering on the outside of the control gear compartment, such that it is clearly visible from the ground with the following information: Rated wattage of luminaire and lamp type

2.6 LED STREETLIGHT LUMINAIRE TEST REPORTS

- 2.6.1 Failure to provide test reports of the following tests called for will result in the rejection of the Tender:
- a) Type test according to IEC 60598-1:2004 and IEC 60598-2-3:2003.
 - b) IP rating test reports for all items offered in accordance with SANS 60529.
 - c) A separate ambient temperature (Ta rating) test report shall be provided, in accordance with SANS 475.
 - d) The test reports shall be issued by SANS or IEC accredited test authority.

2.7 EARTHING

- 2.7.1 The luminaire shall be earthed in accordance with Clause 13 of the Electrical Machinery Regulations of the OHSACT (Act 85 of 1993).
- 2.7.2 Metal parts of luminaires which may become alive in the event of insulation fault and which are not accessible when the luminaire is mounted, but liable to come into contact with the supporting surface, shall be permanently and reliably connected to an earthing terminal and shall withstand the test specified in IEC 60598-2-3.
- 2.7.3 Earth connections shall be effected by means of suitable lugs in a manner avoiding all possibility of electrolytic corrosion.

2.8 WIRING

- 2.8.1 The internal wiring of the luminaires shall be flexible and suitably insulated to withstand the voltage and the temperature.
- 2.8.2 Wiring to the LED module compartment shall be suitably grommited, ensuring a perfect seal between compartments.
- 2.8.3 The supply terminals shall accept 4mm² wires and easily accessible. No part of the cover shall damage the supply wires when closed.
- 2.8.4 Shall have a clamp for fastening supply wires to body of fitting.

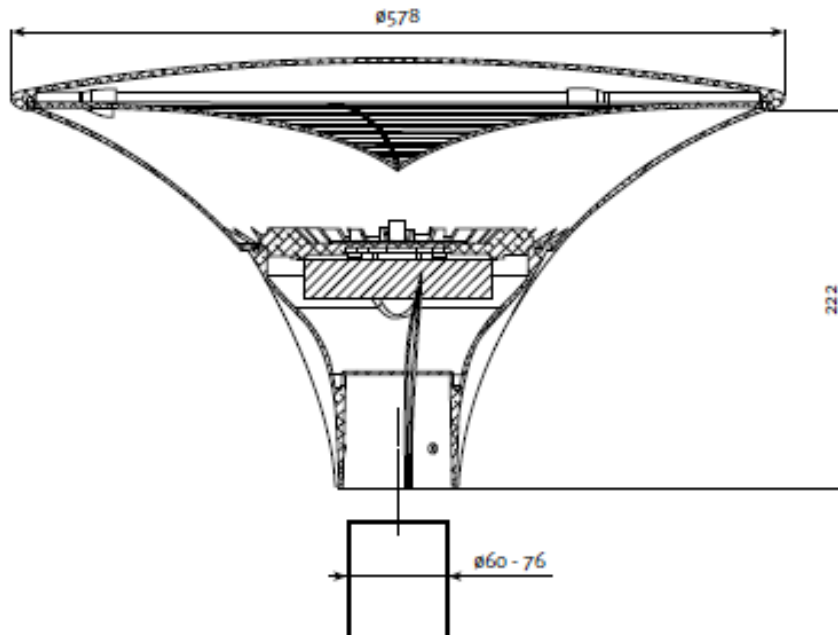
2.9 GUARANTEE

- 2.9.1 All luminaires offered shall have a minimum guarantee period of five years.
- 2.9.2 The scope of this guarantee includes the LED module drivers, luminaire housing, LED module(s), brackets and protector.
- 2.9.3 If luminaires are found to have failed within this period as a result of poor manufacturing processes and/ or poor materials it shall be replaced free of charge by the manufacturer.

3 LED POST TOP SPECIFICATION

3.1 General

- 3.1.1 Only offers for LED post top luminaires which are manufactured in South Africa and supported by the original South African manufacturer.
- 3.1.2 Dimensions and shape of the LED Post Top luminaire shall be similar or equally approved as the below line drawing.

3.2 LED Post Top Area lighting

3.2.1 The LED post top luminaire shall be designed to meet the lighting criteria for Group B roads as required.

3.2.2 The luminaire shall be designed in accordance with the following requirements:

- a) Design life: In excess of 25 years
- b) The Post Top shall be a LED replacement for existing 125W MV and or 70W HPS Post Tops on a mounting height of between 3-6m. The tenderer shall provide a photometric design proving that the offered unit can replace the 125W MV or 70W HPS units and retain the same

lux levels as before.

- c) The luminaire shall be completely glare free. This shall be achieved by incorporating a symmetrical indirect lighting reflector within the luminaire. An asymmetrical reflector shall be available on request.
- d) The luminaire shall incorporate a temperature sensor which monitors the temperature of the LEDs on the PCBs. Once a critical temperature is reached, the current shall be reduced to a safe temperature level. The temperature sensor shall not completely switch off the LEDs at high temperatures, which shall facilitate maintenance to be undertaken during daylight hours.
- e) The power supply or driver shall be able to withstand surges of up to 10kV/10kA by means of an external inline fused surge protection device mounted inside the gear compartment. This surge protection shall be easily replaceable.
- f) The power supply or driver should incorporate a thermal switch to prevent exceeding the case temperature for maximum life time of equipment. The lifetime of the power supply or driver shall be 100 000hrs with 90% survival over the lifetime.
- g) Minimum IP rating of the light compartment, including driver compartment: IP66.
- h) The protector shall be smooth, for easy cleaning, and shall be manufactured of impact resistant UV stabilised polycarbonate (IK 08). The housing shall be robustly constructed, weather proof, hail proof, insect proof, corrosion proof, ultraviolet light resistant and vandal resistant.
- i) The top cover of the luminaire shall be manufactured of Plastamid and in the specified colours as used by George municipality
- j) The Post Top luminaire shall be certified, in terms of SANS 60598, to operate at an ambient temperature of -15°C to 45°C. The thermal design shall be particularly designed for African exterior conditions, i.e. high temperatures, high pollution, corrosion resistant.
- k) The LED life expectancy shall be 60,000 hours at 80% lumen maintenance. (Documentary evidence from the LED manufacturer, by means of an appropriate datasheet, confirming the statistical correlation, shall be provided).
- l) Use of high efficiency LED's (> 90 lumens/watt: Absolute photometry) CRI > 70. Documentary evidence of compliance to this clause shall be submitted with the tender.
- m) Colour temperature shall be neutral white (4000K) with an option to be supplied in warm white (3000K). A report from the LED vendor, for LED's used in the luminaire, shall be submitted, which shall include the following documentary evidence:
 - Measured LED junction temperature for a given test condition and extrapolated for an ambient temperature of 35°C.
 - LED drive current.
 - LED manufacturer data that clearly correlates LED junction temperature and LED drive current to lumen maintenance.
 - The LED datasheets, indicating the Byy, Lxx data, as provided by the LED manufacturer.
- n) The luminaire spigot housing shall be constructed of marine grade high pressure die cast EN 1706 AC-44300 aluminium. Tenderers shall submit a metallurgical report from an independent metallurgist confirming the grade of aluminium for all the luminaires offered.
- o) The spigot shall be equipped with 3 x M8 hexagon screws for fastening on the bottom entry pole.
- p) The control gear and LED engine shall be incorporated into the spigot housing for heat dissipation. The power supply connection must take place inside the spigot.

3.3 SPIGOT ENTRIES

- 3.3.1 Spigot entries shall be designed to fit easily over the existing bottom entry and shall comply with Table 1 of SANS 1088 as follows: For Type 2 luminaires (bottom entry): Nominal size 76 x 75 mm

3.4 POWER SUPPLY

- 3.4.1 The power factor shall be rated at ≥ 0.95 .
- 3.4.2 The power supply shall be removable and shall be suitable for operation with the specified rating of the lamp on a 120-277 VAC 50Hz single phase system.
- 3.4.3 Operating temperatures shall be from -15deg to +60deg on the housing (case temperature).
- 3.4.4 Operating humidity shall be from 20% to 95%.
- 3.4.5 The control gear shall incorporate a thermal switch for protection when exceeding the case temperature.
- 3.4.6 Provisions shall be made to withstand surges up to 10kV/10kA.
- 3.4.7 The unit shall be EMC compliant to the SANS 55015 and SANS 61347-1 standard.
- 3.4.8 The unit shall be able to be supplied with a recessed down facing daylight sensor on request.

3.5 LED STREET LIGHT LUMINAIRE TEST REPORTS

- 3.5.1 Failure to provide test reports of the following tests called for may result in the rejection of the Tender:
 - a) Type test according to SANS 60598-1:2004 and SANS 60598-2-3:2003.
 - b) IP rating test reports for all items offered in accordance with SANS 60529.
 - c) A separate ambient temperature (Ta rating) test report shall be provided, in accordance with SANS 475.
 - d) The test reports shall be issued by SANS or IEC accredited test authority.

4 ITEM DESCRIPTIONS

4.1 ITEM DESCRIPTION 1

- a) The different LED luminaires shall be designed to meet the lighting criteria for the different road classes (SANS 10098-1) as indicated below: Item 1: LED Luminaire to comply to A2 Major Roads, for Speed limits not exceeding 90 km/h, with a staggered configuration and traffic volume of 600 vehicles per hour per lane.
 - b) Item 2: LED Luminaire to comply to A2 Major Roads, for Speed limits not exceeding 90 km/h, with a single side configuration and traffic volume of 100 vehicles per hour per lane.
 - c) Item 3: LED Luminaire to comply to A3 Important urban traffic routes for speed limits not exceeding 60 km/h; and traffic volume of 300 vehicles per hour per lane.
 - d) Item 4: LED Luminaire to comply to A4 Connecting roads, local distributor roads, residential major roads and traffic volume of 200 vehicles per hour per lane.
 - e) Item 5: LED Luminaire to comply to B2 Residential roads with medium volume of traffic.
 - f) Item 6: LED Post Top Luminair.e to comply to B2 Residential roads with medium volume of traffic
- 4.1.2 The parameters that must be used for the configuration of the LED fitting in the simulation software package are indicated in the following table under Design Criteria.

General Conditions of Contract

1. **Definitions:**
1. The following terms shall be interpreted as indicated:
 - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 “Day” means calendar day.
 - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
 - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
 - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 “Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14 “GCC” means the General Conditions of Contract.
 - 1.15 “Goods” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
 - 1.16 “Imported content” means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are

inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application:

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General:

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards:

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information inspection:

5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the provider in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.

5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the provider's performance under the contract if so required by the purchaser.

5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights:

6.1 The provider shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

6.2 When a supplier developed documentation / projects for the municipality or municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality or municipal entity.

7. Performance security:

7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

(a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or

(b) a cashier's or certified cheque.

7.4 The performance security will be discharged by the purchaser and returned to the provider not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing:

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents:

10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.

11. Insurance:

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. Transportation:

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental services:

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the provider for similar services.

14. Spare parts:

14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty:

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment:

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices:

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the provider in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders:

- 18.1 In cases where the estimated value of the envisaged changes in purchase does not exceed 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment:

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts:

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the Supplier's Performance:

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.

21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties:

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default:

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction;
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
24. Anti-Dumping and Counter-Vailing duties and rights:

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure:

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency:

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes:

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Notwithstanding any reference to mediation and/or court proceedings herein, (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and

(b) the purchaser shall pay the supplier any monies due to the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of liability:

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language:

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law:

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices:

31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.

31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties:

32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.

32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of contracts:
- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.
34. Amendment of contracts:
- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
35. Prohibition of restrictive practices:
- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties are contemplated in section 59 of the Competition Act No 89 of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
