A compulsory clarification meeting with representatives of the Employer will be held at **10:00 on Tuesday, 7 February 2017** at the Civil Engineering Committee Room, 1st Floor, George. No Tenderers will be allowed after 11:15.

Tenderers must be registered with the CIDB and it is estimated that tenderers should have a grading designation of **8CE** or higher.
